(For those candidates who have confirmed their seat at NITK Surathkal and have completed PI Reporting by paying the balance fee at the CCMT/CCMN portal after three regular rounds and/or two special rounds of CCMT/CCMN)

Instructions to the candidates:

The candidates who have got their seats confirmed for M.Tech/M.Sc programmes of NITK Surathkal and paid the balance fee after the third regular round and /or Special Round 2 (Round 5) of CCMT/CCMN are required to complete the provisional admission at NITK portal during 29th August 2021 to 3rd September, 2021.

The candidates who have confirmed their seats in M.Tech/M.Sc programmes of NITK Surathkal after the Special Rounds are required to pay the balance fee (if not paid) essentially through the CCMT/CCMN portal through CCMT portal at the earliest to complete the online admission (PI reporting) formalities at the CCMT/CCMN portal. For any updates or procedure regarding balance fee payment, please visit the CCMT/CCMN website and follow the CCMT/CCMN guidelines.

Further, the provisional admission would be done at NITK Surathkal through **online mode** due to the COVID-19 pandemic situation, during **29th August 2021 to 3rd September, 2021**, to those candidates **who have confirmed their seat for M.Tech./M.Sc. at NITK and have completed PI Reporting by paying the balance fee at the CCMT/CCMN portal.** The login credentials for NITK IRIS admission portal

<https://iris.nitk.ac.in/admission/admissions/login.> will be sent to all such candidates by

email. The email will be sent before 29th August 2021 to those candidates who have paid the balance fee at CCMT/CCMN on or before 5.00 PM on 27th August 2021. The login credentials will be sent to other candidates after the updates about balance fee payment is received. The email will be sent only to the candidate email id. registered with CCMT/CCMN.

The online Admission portal will be made active from **29th August 2021** (Sunday). The candidates are required to login to the admission portal through the above link, pay the required hostel fee of Rs.9300/-, fill-up the Online Admission form and upload all the necessary documents listed below to be considered for provisional admission to **M.Tech / M.Sc** at NITK Surathkal. The online document verification by NITK officials will be carried out during **31st August 2021 - 6th September 2021** and Provisional Admission Orders will be issued to the candidates online after the verification. During the document verification, candidates may be contacted by email, if there is any query on the uploaded documents. The candidates are required to check their email frequently during this period and respond to the query accordingly.

The classes for first semester M Tech and MSc students for the academic year 2021-22 would be held in online mode (until further notice) and the date of commencement of the classes will be communicated in due course of time. The Academic calendar for the semester will be made available in the Institute website soon.

The scanned copies of the following original documents are to be uploaded by the candidate at the time of online admission at NITK IRIS portal.

1. Provisional admission letter downloaded from the CCMT portal along with the Proof of payment of balance fee to CCMT/CCMN
2. Original GATE score card (2019/2020/2021) for M Tech candidates and JAM score card (2021) for M.Sc candidates.
3. Photo ID proof as per Govt. of India norms (Copy of Aadhar Card is compulsory)
4. Original Certificate of Date of Birth issued by competent authority/Class X (High School) Board Certificate as proof of date of birth
5. Original Mark sheet of Class XII
6. Original Grade/Mark sheets of qualifying examination for all semesters/years
7. Original Degree / Provisional certificate, if degree is completed
8. Original Course completion certificate from the Head of the University/Institute, if result is awaited
9. An Undertaking by those candidates whose result is awaited (Annexure C)
10. Original Certificate of category (OBC-NCL/SC/ST), if applicable, as per Government of India format, issued by the competent authority. In case of OBC-NCL category, the certificate must be issued on or after April 1, 2021.
11. Original Income and Assets Certificate for EWS candidates, if applicable, as per Government of India, issued by the competent authority. The certificate must have been issued on or after April 1, 2021.
12. Undertaking to be submitted by OBC-NCL candidate in the format provided (Annexure A)
13. Original Certificate for Persons with Disabilities (PWD), if applicable, issued by the competent authority.
14. Undertaking to be submitted by PWD candidate in the format provided (Annexure B) to be given on Non-Judicial Stamp Paper of minimum Rs. 50/- and duly notarized)
15. Passport size photograph.
16. Medical fitness certificate in the format provided

17. Original Conduct Certificate from head of the institution last attended
18. Original Migration certificate (for candidates from outside Karnataka) of last institute/university attended
19. Original Transfer certificate from the head of the institution last attended

(If any certificate is in language other than Hindi or English or Kannada, translation of the same in English is to be produced certified by the competent authority)

Hostel Facility

Hostel facilities are available to all the students. Hostel Room Allotment will be done to the admitted students whenever they are physically present at the Institute.

Important Note

- (1) *Candidates belonging to OBC –NCL or EWS category are required to submit the certificates in the prescribed format available in the NITK website (i.e. www.nitk.ac.in) and issued on or after April 1, 2021. The certificates issued earlier than the prescribed date are not acceptable and no affidavit or undertaking in this regard will be acceptable during the online admission at the Institute. So, all such candidates must arrange to get their valid certificates before the online admission date. All the OBC-NCL candidates need to submit a declaration (Annexure A) along with the certificate. The prescribed format for the declaration may be downloaded from the NITK website*
- (2) *Caste certificate (SC/ST/OBC-NCL) issued by Maharashtra State must be validated by Social Welfare department (in case of SC and OBC-NCL category) and Tribal Welfare department (in case of ST category) of Maharashtra Government. The SC/ST/OBC-NCL candidates of Maharashtra State have to produce their caste validity certificate in the format available on CCMT website at the time of online admission at the Institute. No affidavit or undertaking in this regard will be acceptable during the online admission at the Institute.*
- (3) *The candidates who belong to PWD category must submit the certificate issued from a competent authority in the prescribed format available in the NITK website (i.e. www.nitk.ac.in). They also need to submit an undertaking (Annexure B) to be given on Non-Judicial Stamp Paper of minimum Rs. 50/- and duly notarized along with the certificate. The prescribed format for the undertaking may be downloaded from the NITK website.*
- (4) *The candidates whose examination for Bachelor's degree study has not been completed or who are awaiting for their result, must submit a Course completion certificate duly signed by the Head of their Institution in the prescribed format. The prescribed format is available in the NITK website. A self -declaration in this regard is not acceptable. Such candidates are required to submit their remaining marks cards and degree certificates on or before 30th September 2021. They should also submit an undertaking in the prescribed format (Annexure C) available in the NITK website along with the course completion certificate.*
- (5) *The candidates who do not have or are not able to get the conduct certificate, transfer certificate and migration certificate presently, may submit the same on or before 30th September 2021. However, such candidates may write a request letter to Dean (Academic), stating the reason for not submitting these certificates during online admission and also that they would submit the same on or before 30th September 2021. **This letter should be uploaded on the IRIS portal. The letters sent by email or any other means will not be accepted.** However, all the other listed documents (as applicable) are to be submitted without fail.*
- (6) *All the original certificates and documents of the candidates who are provisionally admitted to NITK through online admission mode, will be verified at NITK whenever they are called for physical reporting at a later date. The dates for Physical reporting to the campus would be notified, as and when such a decision to call the students to campus is made.*
