The Govt. of Tamil Nadu have issued orders to grant Scholarship to the students belonging to BC/MBC/DNC Communities who are pursuing UG/PG Courses in the Institutions of Govt. of India like IIT, IIM, IIIT, NIT and Central Government Universities from the year 2019-20.

#### **Conditions:**

1. The student should belong to BC/MBC/DNC
2. The student should be a native of Tamil Nadu.
3. The student should pursue UG/PG Courses in IIT, IIM, IIIT, NIT and other Central Government Universities.
4. The family annual income should not exceed Rs.2.00 Lakh Per Annum.

#### **Scholarship Amount:**

1. The Government will reimburse to the students Scholarship amount comprising of Tuition Fee, Special Fee, Exam Fee and other compulsory Fees as prescribed by the Institution or Rs.2.00 Lakh per year whichever is lesser.
2. The above scholarship amount will be reimbursed to the student every year for the entire duration of their UG/PG Courses.
3. If more no. of application are received, the eligible students will be shortlisted with respect to their marks secured in +2 public exams / U.G examinations.
