**NOTICE INVITING QUOTATIONS**

The National Institute of Technology Karnataka, Surathkal (in short - NITK, Surathkal or Institute) is an autonomous Institute of the Govt. of India [under the Ministry of Education] imparting technical and science education. The Institute intends to “**Providing Deco grill to the windows at southern and northern wing in ground and Second floor of Sports Complex building**, in NITK”. In this connection, sealed quotations are invited by the undersigned subject to the terms and conditions enumerated here under from the agencies so as to reach this office on or before **12.08.2022 by 3:00PM**. The quotations shall be opened on the same day if possible.

1	Providing, Fabricating and fixing in position anodized Aluminium Deco grill (7mm thickness) of approved pattern and size in Aluminium matt finish or glossy finish anodized sections of size 25x1mm thick Aluminium tabular square section all-round frame, vertical and horizontal support with 22x12x1mm thick Aluminium grill section are cut to the required lengths, joints mitred and corner grinded sub dividing frames to be tenoned and riveted to the frames. The assembled frame should be stiffened with corner angles strips and fixed with screw, rawl plugs and teak wood gutties to RCC columns or masonry, on sides of RCC lintels or beams chiseling including scaffolding and making good with cement mortar to match the original surface. All the aluminium section used should be treated for removal of any rust and prevention of further rust formation and coated with greasy materials for non-adherence of mortar or any other sticky materials.
