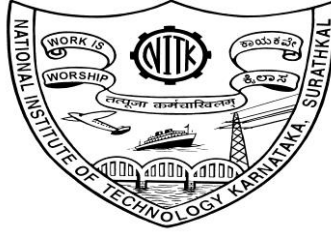

### Specifications of the Cricket Net Practice Zone:

1. 3 Cricket net practice Zone, one Concrete flooring and two Mud pitch with raised level from the existin ground by 6 inch.
2. Dimensions:  
Length 45 feet, Width 12 feet, Height 12 feet
3. All the three Cage should be fitted with openeable Metal netted Gate of 5 feet height with closure.
4. Concrete floor should be fine plastered.
5. Back side covering should be of metal net.
6. Outside and inner net walls should be of Premium quality Nylon Cricket Nets.
