### Call for Applications for Financial Assistance for the academic year 2023-24

Applications in the prescribed format for financial assistance are invited from eligible regular full-time SC/ST students pursuing **B.Tech./M.Tech./MCA/MBA/M.Sc./PhD degrees** for the year 2023-24. The last date for submission of completed application along with all the necessary enclosures at the SC/ST Cell office is **09.02.2024**. #### Eligibility:

1. The annual family income of the student should be less than Rs. 4.5 Lakhs.
2. The student should not be in receipt of any other scholarships from any state/central Govt./PSU/Private organizations. An undertaking in the prescribed format in this regard is to be submitted along with the application.
3. The student should have secured a minimum CGPA of 5.0 up to the previous semester. **This is not applicable for PhD and 1<sup>st</sup> semester B.Tech./M.Tech./MCA/MBA/M.Sc. students.**

#### Kind of Financial Assistance Available:

##### I. B.Tech./MCA/MBA/M.Sc. students:

1. Actual Hostel/Mess fees paid at the NITK Hostels office.
2. Hostel room rent paid at the institute.
3. A sum of upto Rs. 45,000/- as a one-time support towards purchasing of a laptop.
4. A sum of upto Rs. 6,000/- per year towards purchasing of Books/stationery required for academic purposes.
5. Academic Performance Incentive of : Rs. 18,000 for scoring:  $8 \leq \text{CGPA} \leq 10$   
Rs. 12,000 for scoring:  $6.5 \leq \text{CGPA} < 8$

1. A sum of upto Rs. 45,000/- as a one-time support towards purchasing of a laptop.


